

<p>Note:</p> <p>(i) Tender schedules are to be prepared with utmost care, following all the existing provisions in the code as also Administrative instructions without fail, after detailed site inspection and soil investigations, wherever necessary, eliminating as far as possible the need for bringing any new items during execution of works.</p> <p>(ii) These tender schedules may be approved by the JAG/SAG officers. Vetting of tender schedule should be necessary only in the rare urgent cases where tenders are called without sanction of detailed estimate. Pre-vetting will also not be necessary in case of zonal works and revenue works in Open-Line for which detailed estimates are not to be framed.</p> <p>(iii) Estimate will generally not be split to bring the value of tender invitation within power of lower authority. For making tender packages on projects, approval of HOD/PHOD shall be taken.</p>

In case of works quotation also a suitable work order/agreement incorporating all terms and conditions as specified in the letter calling quotations should in variably be issued by executive so as to safeguard the financial interest of the Railways. Measurement of the work completed, completion of work, penalty for sub-standard work, security deposit, maintenance period, tax deduction at source and payment terms etc. must be clearly defined without any ambiguity. Such work order/agreement is not require to be vetted by associates finance.</p> <p>2. While inviting and accepting quotations item no.12 (a) of SOP on works matters should be referred to and all the provisions mentioned there in followed.</p>
