Term and Condition:

1. Application can be Parties/Corporates/Hospitals/Group of Hospitals (with Memorandum of Understanding (MoU).
2. The contract will be for a period of two year, renewable subject to satisfactory Performance of selected party.
3. Railways will provide space, electricity and water connectivity free of cost at Agra Cantt., Mathura Jn. Raja Ki Mandi & Agra Fort.
4. The selected party shall construct the booth for the Medical facility as per plan approved by Railways at his own cost and by mobilizing his own resources.
5. The selected party will employ staff to provide free Emergency Medical Assistance to the bonafide passengers with journey ticket.
6. The Centre should be kept functional round the clock.
7. All necessary Medical Equipments for providing basic life saving services will be installed by the selected party.
8. Apart from other general medicines, Life saving medicines will also be stocked for providing emergency care.
9. Skilled paramedical staff will be available round the clock for the Medical Assistance to the passengers coming to the centre.
10. The selected party should not canvas/promote their hospital through this centre.
11. The personnel employed at the Centre shall provide all possible medical assistance to passengers coming to the centre.
12. Passengers requiring advanced medical care should be shifted to the nearest Hospital by calling for the State Government Ambulance Service (108).
13. Railways shall be indemnified of any claim/dispute arising on account of usage of the service of the Centre by the passengers.

14. Railways will not be responsible for any outcome arising due to medical attention provided at the Centre.
15. The selected party may display health related messages inside the Centre to educate the passengers who visit the centre.
16. The contract may be terminated by either party by giving one month notice and the selected party will be permitted to take back any equipment installed by them on Termination.
17. Any dispute arising out of Memorandum of Understanding (MoU) with selected Party/ Organizations/Corporate/Hospitals/Group will be settled by Divisional Railway Manger, Agra Division, North Central Railway Agra Cantt., whose decision will be final and binding on both Railways and selected party.
18. Selection will be made in the following order of preference:
 - i. Individual Hospital
 - ii. Group of Hospital
 - iii. Corporate

It there is more than one applicant in any category, Selection will be made through draw of lots.

19. Interested Parties/ Organizations/Corporates/Hospitals/Group may apply with their plan/drawing/design of the proposed centre and its specifications, capability and experience in such nature of work.
20. Interested Parties/ Organizations/Corporates/Hospitals/Group will have an option to deliver a presentation of the proposed centre in the one-to one meeting and can share the innovative ideas, if any, with complete specifications.
21. On completion of the meeting, short listing of the Parties/ Organizations/Corporates/Hospitals/Group will be done for further processing.
