#### Note:-

- (i) Candidate must report in Principal Chief Medical Director's office, 1st floor, Mandakini Building, 'G' Block, Subedarganj, Allahabad latest by **900 Hrs**. on 21.08.2018 (Tuesday).
- (ii) Candidate must submit their applications in duplicate on the prescribed proforma enclosed on 21.08.2018 (Tuesday) at the venue of Walk-in-Interview.
- (iii) In case, the numbers of candidates are more and they cannot be interviewed on the scheduled date/day, they will be interviewed on the next working day/days. As such, if needed, the candidates should make their own arrangement for stay for a period of two days and should come accordingly.

Remuneration for the doctors of open market: Rs.75,000/- for General Duty Doctor and Rs.95,000/-(1st year), 1,05,000 (2nd year onward) for Specialist Doctors per month fixed, if Govt. accommodation is not provided. If Railway accommodation is provided an amount equivalent to the sum of House Rent Allowance and License Fee of the accommodation provided will be deducted.

Remuneration for Retired Government Medical Officers of Government/Central Government/IRMS Officers (Railways): Rs. 75,000/- for General Duty Doctor and Rs.95,000/-(1st year), 1,05,000 (2nd year onward) for Specialist Doctors per month fixed (subject to the condition that remuneration + pension drawn by Retired Government Medical Officers of State Government/Central Government/IRMS officers (Railways)} should not exceed the last pay drawn), if Govt. accommodation is not provided. If Railway accommodation is provided an amount equivalent to House Rent Allowance payable to a fresh entrant to Group 'A' Jr. Scale and license fee of the Railway accommodation, so provided shall be deducted from the monthly remuneration payable to the CMP.

<u>Age for the doctors of open market:</u> Candidates should not have completed more than 60 years of age as on **01.01.2018**. However, age relaxation of 5 years for SC/ST and 3 years for OBC candidates is admissible.

Age for Retired Government Medical Officers of State Government/Central Government/IRMS Officers (Railways):- Candidates should not have completed more than 67 years of age as on 01.01.2018.

## Terms and condition for the doctors of open market:-

The engagement of Doctors would be on contract basis initially for a period of one year, which is extendable on annual basis upto a maximum 12 (twelve) terms or till attaining the age of 60 years whichever is earlier as per administrative requirements on the basis of assessment of performance of CMPs. However, the services of these doctors can be terminated before the expiry of one year after giving 15 days notice on either side. Railway Administration will be at liberty to terminate the contract of the doctor with immediate effect by paying honorarium in lieu of 15 days notice period, if the circumstances, so warrant. The services rendered as contract doctor is a stopgap arrangement and will not have any bearing in respect of consideration of their period in case of their subsequent regular selection through UPSC. It will also not confer upon them any right for regularization or permanent absorption in the Railways. Contract shall also be terminated, if the CMP is found to be mentally or physically incapacitated.

#### No private practice is allowed.

## <u>Terms and condition for Retired Government Medical Officers of State</u> <u>Government/Central Government/IRMS officers (Railways):-</u>

The engagement of Retired doctors as CMPs shall be for a maximum of **07** (seven) terms or till attaining the age of **67** years whichever is earlier and each term of engagement shall not exceed more than one year, a fresh contract shall be entered. The contract shall be entered into for a period of one year or less from the date of entering into the contract. Period of contract shall not be extendable on any ground. However, the Railway administration shall reserve the right to enter into fresh contract with the Retired Government Medical Officers of State Government/Central Government/IRMS officers (Railways) for another term. The engagement shall purely be on contract basis for a period of one year or till the regular incumbent joins or on Retired Government Medical Officers of State Government/Central Government/IRMS officers (Railways) attaining the age of 65 years, whichever is earlier. The Retired Government Medical Officers of State Government/Central Government/IRMS officers (Railways)

engaged as Contract Medical Practitioner shall not have any claim or right for his/her continuity in service or automatic extension of the term of contract. During the validity of the contract, the CMP shall be at liberty to terminate the contract for betterment of his/her career or on any other grounds by giving 15 days notice to the Railways. The contract can also be terminated by the Railways at any time during the contract by giving 15 days notice without assigning any reason whatsoever. Contract shall also be terminated, if the CMP is found to be mentally or physically incapacitated.

# No private practice is allowed. Note:-

- (i) The contract Doctors shall not be entitled for Railway quarter etc. as a matter of right. However, if such a quarter is available, they will be provided accommodation. The detailed instructions with regard to their duties while on contract with the Railways, shall be given to them in the event of their selection along with the offer of engagement.
- (ii) Willing candidates should bring their application form along with **Original and Attested** copies of all Certificates & Mark Sheets, duly filled up on the prescribed format with them. **No TA/DA is admissible for this interview**.
- (iii) Administration has a right of transfer to selected candidate(s) any time in future from Central Hospital/Allahabad to Divisional Hospitals/ Health Units situated in the jurisdiction to NCR, if required. The CMP Specialist Doctors so selected shall also have to carry out general duties as and when required by Railway Administration in addition to their specialty work.
- (iv) If specialists do not turn up or not found suitable for the posts, the post will be filled up by General duty Medical Practitioners.
- (v) The number vacancies may be changed as per requirement of the administration.
- (vi) The notification can be downloaded from N.C. Railway website <a href="https://www.ncr.indianrailways.gov.in">www.ncr.indianrailways.gov.in</a>.
- (vii) After approval of the panel by competent authority, the panel will be uploaded on same day at NCR's website <a href="www.ncr.indianrailways.gov.in">www.ncr.indianrailways.gov.in</a>. The suitable candidates will be called through speed post/registered letter, Telephone calls and SMS to report in Central Hospital, Allahabad for posting. The candidates who do not report within the stipulated date and time will forfeit their chance of contract engagement and such engagement will be offered to the next empanelled candidate.
- (viii) The empanelled candidate(s) will undergo medical examination and will execute a "Contract Agreement" notarized and duly executed to concerned Personnel Branch before joining the post. In this regard, instructions will be issued in the offer of engagement of the candidate(s).
