Sub: Relaxation of eligibility criteria for Startups (recognized by Department of Industrial Policy and Promotion, Ministry of Commerce and Industry) in Works tenders.

Ref: Railway Board letter No. 2012/CE-I/CT/0/5 dated 24.04.2019.

Vide Railway Board's letter under reference, instructions have been issued to all concerned that General Manager, on the recommendation of PHOD/CHOD of the department inviting the tender and associate finance, can relax the applicability of eligibility criteria to 'Startup' firms (recognized by Department of Industrial Policy and Promotion, Ministry of Commerce and Industry), on case to case basis.

2. However, representations have been received from 'Startup' firms complaining that the Board's above relaxation is not being utilised by Railways/PUs to give opportunity to new 'Startup' firms, not having required technical eligibility criteria and thus, the basic purpose of Govt. of India to promote 'Startup' firms is getting defeated.

Board has taken a serious view in the matter and it is requested that relaxation in eligibility criteria for 'Startup' firms (recognized by Department of Industrial Policy and Promotion, Ministry of Commerce and Industry), should be made in future tenders as and when opportunity is available in terms of Railway Board letter cited above to comply with Govt. of India's initiative to promote 'Startup' firms.
