| ASM(SM/Dy SS/SS (Vide Board's letter No.2018/Safety(DM)/18/1 dated 22.05.2018) | For services rendered in train passing duties only. It is desirable that in order to calculate the length of qualifying services in train passing duties, suitable entries be made in SR of the employee. |
