Sub: Coverage under Railway Services (Pension) Rules, 1993, in place of National Pension System, of those Railway employees whose selection for appointment was finalized before 01.01.2004 but who joined Railway service on or after 01.01.2004.

The Board's letter (RBE No 28 / 2020) under reference has already been circulated vide North Central Railway's NCRPS No. 5848 / 2020 dated 04.03.2020.

As per above RBE, such Railway servants who were declared successful for recruitment in the results declared on or before 31.12.2003 against vacancies occurring before 01.01.2004 and are covered under the National Pension System on joining service on or after 01.01.2004, may be given **one time option** to be covered under Railway Service (Pension) Rules, 1993.

The willing staff, coming within the purview of the provisions contained in RBE 28 / 2020, **may submit his / her option latest by 31.05.2020 on given proforma**, to cover his/her case under the Railway Service (Pension) Rules, 1993 (Old Pension Scheme). **The relevant documents in support of his / her claim may also be enclosed by the willing staff.**
