**Sub: Private loans taken by Railway employees from banks/ non- Railway thrift societies etc.**

\*\*\*

Of late references are being received from Banks / Non- Railway Thrift Societies etc. seeking Board's intervention for recovery of loan taken by Railway employees therefrom. It is also seen that such employees have submitted undertaking signed by Railway authorities agreeing to recover loan repayments from their salary and remit the same to banks, if so requested by banks.

In this regard, it is stated that extant rule do not permit such arrangement of recovery of private loans taken by Railway employees from banks / non- Railway thrift societies etc, from their salary for remittance to such banks/ societies. Railway administrations should not act as a guarantor on behalf of the Railway employees in such cases. Necessary instructions in this regard may therefore be issued to all concerned.

Further, whenever, instances of taking loans, non-repayment etc by Railway employees on their own comes to the notice of Railway administrations, it should be examined whether there has been any violation of Railway Service (Conduct) Rules, 1966. If so, necessary action may please be taken against such employees.
