

Sub: **Refresher Courses** -Online examination (refresher) being conducted for Safety Category Running Staff due to COVID-19.

Vide letter No. E(MPP)/2003/3/10 dated 03.06.2004, instructions have been issued, wherein it has been stated that 30% marks should be for subjective type questions and 70% marks for objective type questions for Refresher Courses Examination for Safety Category Running Staff.

Due to the situation of COVID-19, Northern Railway has requested for conducting 100% objective type question for Online Refresher Courses Examination for Safety Category Running Staff till physical training starts in Zonal Railway Training Institute.

The matter has been considered in Board and it has been decided that Zonal Railway may decide the best course of action, as per situation of their State and as per need of the hour. Railway may either adhere to existing rule of 30% marks for subjective type questions and 70% marks of objective type questions or 100% objective type question for Online Refresher Courses for Safety Category Running Staff till September 2020. Thereafter, the situation may be reviewed.
