A reference has been received from NFIR requesting Board to grant Nursing allowance to Nursing Superintendents (Staff Nurse) who are engaged in Railways on contract basis as is admissible and being paid to regular Nursing personnel.


2. Emoluments admissible to Para-medical staff in Group 'C' engaged on contract basis at present are as contained in Board's letter No. 2017/Trans/01/Policy/Pt.I dated 12.04.2018 wherein there is no provision for payment of Nursing allowance.

3. To enable this issue to be considered in totality, Railway may please advise the following to this office urgently:-

- The terms of contract agreed to by Nursing Superintendents (Staff Nurse) engaged on contract basis before they have taken up employment and where their emoluments would have been clearly specified.
- Number of Nursing Superintendents (Staff Nurse) engaged on Railway at present:
 - within sanctioned strength.
 - above sanctioned strength.
- Duration of such engagements of Nursing Superintendents (Staff Nurse).
- Nature of work entrusted to contractual Nursing Superintendents (Staff Nurse).
