Willing suppliers may apply within 21 days of from the date of this advertisement.

Following conditions are mandatory;

1. Firm should supply the indented Medicines/Surgical/Other items 24 hours/seven days a week.
2. Firm should have a valid authority/license from state/central government for retail sell of medicines/surgical items.
3. Firm should be registered for GST and other applicable laws/rules.
4. Firm shall supply the indented medicines/surgical/other items on credit basis.
5. Rail Administration reserves the rights to get the supply tested in Government/private approved laboratory. In case any supply is found sub-standard, Rail Administration reserves the rights of cancelling the registration and recover the cost of test from the supplier.
6. Supplier will have to ensure supply on all the days and round the clock. Suppliers has to ensure emergency supply/urgent items to be supplied on urgent basis on short notice.

TERMS & CONDITIONS FOR REGISTRATION AS APPROVED RETAIL SUPPLIER OF
MEDICINE/SURGICAL/OTHER ITEMS

General condition applicable:-

1. Firm should be open for 24 hours and seven days a week.
2. Firm should have a valid license for dealing in medical and surgical items as a Retailer.
3. Firm should comply with statutory regulations like Drug and Cosmetic Act, Pharmacy Act and other rules as imposed by Central and State Government time to time.
4. Firm should be registered for GST as applicable in Uttar Pradesh.
5. Registered suppliers have to supply medicine /surgical items manufactured by reputed firms only.
6. Railways reserve the right to get the supply tested in Govt. approved laboratories. In case any of the supply is found sub-standard, Rail Administration reserves the right to cancel the registration and to recover the cost of test from the supplier.
7. Supplier will indemnify the Railway for any liability arising due to defective/sub-standard supply.
8. Supplier should have facility of computerized billing, challan etc. to facilitate quick paper work and should have facility of telephone, fax, E-mail for quick communication.
9. Supplier will have to ensure supply on **ALL the DAYS** and **ROUND THE CLOCK**. Supplier has to ensure emergency supply/ urgent items to be supplied on urgent basis on short notice.
10. Representative of supplier must visit the hospital once a day at 17.00 hrs. to collect orders. All items ordered are to be supplied by 11.00 hrs. on next day.
11. Usually whatever brand of Medicine has been asked, only that brand should be supplied. Only in exceptional circumstance if original brand of medicine is not available, then equivalent product of another reputed firms to be supplied. Railways reserve the right to accept/reject the said supply.
12. If supplier fails to deliver supply in time, a penalty of Rs. 100/- per item per patient will be imposed on the supplier, and Railways will be free to purchase the item from alternative source and cost difference, if any; will be recovered from the supplier.

13. Supplier should have the capability to meet supply order. Supplier should have turnover of at least 25 to 30 Lakhs per annum.
14. Medicine shop should be located within five (05) Km. from the railway hospital Agra Cantt. All conditions remaining equal, preference will be given to the supplier nearest to the hospital.
15. In terms of EMD Rs. 75000/ (Rs Seventy five Thousand Only) DD in original issued by any nationalized/scheduled bank in favor of Sr. Divisional Finance Manager, N. C. Railway, Agra Cantt should be enclosed with the application form, **otherwise registration form will be treated as cancelled.**
16. After registration of retail suppliers, quotations will be invited from them once or twice in a year to select the suppliers. Selection will be based on discount percentage on MRP (including of all taxes) offered. No. separate trade tax/local tax will be payable.
17. In the event of any dispute between Railways and the supplier as to the respective right and obligation of the parties hereunder or meaning of any article or conditions, such dispute shall be referred to sole arbitration of an officer of the Railways who shall be nominated for this purpose by the General Manager, N.C. Rly, and his decision shall be final, conclusive & binding on the parties.
