Vide Board's letter under reference above, Zonal Railways/PU's were advised to either adhere to existing rule of 30% marks for subjective type questions and 70% marks of objective type questions or 100% objective type question for Online Refresher Courses for Safety Category Running staff till Sept 2020. The instructions were to be reviewed after September 2020.

Keeping in view the present situation of COVID-19, the matter has been reviewed and it is advised to continue with the existing arrangement till 31<sup>st</sup> March 2021.
