

**Sub: Continuity in service of IRHS officers on attaining the age of 62 years and upto the age of 65 years.**

**Ref: Board's letter No.2018/E/SCC(GC)/13/53 dated 21.02.19.**

Attention is invited to Board's letter cited above, stipulating therein that salary of doctors who have opted to serve on clinical posts will be charged against existing vacancies in the lower grade and also that there shall be vertical floating of posts which however shall be limited upto the level of 5 % of the total cadre posts.

2. The matter regarding extension of service of IRHS officers beyond the age of 62 years and upto the age of 65 years have further been reconsidered by Board and it has been decided that:

(i)	The cap of 5 % of total cadre strength may be applied only at HAG and above level
(ii)	The on-roll strength shall not exceed the sanctioned strength of doctors at any point of time.
(iii)	The doctors willing to serve till 65 years of age shall submit their willingness 6 months in advance and the same should be forwarded to Railway Board with the recommendation of GM regarding requirement of doctors and their suitability for further continuation on clinical post

3. The above guidelines may be followed strictly and necessary action may be taken accordingly.
