**Subject: Holding of Centralised Computer based objective type tests (CBT) for 70% Selections and 30% LDCEs for promotion to Group 'B' Posts in the Organised Departments (except Accounts & IRPFS)**

**Ref: Board's letters No.E(GP)2018/2/31 dated 11.9.2020, 21.9.2020, 30.9.2020, 16.10.2020, 16.12.2020 & E(GP)2018/2/18 dated 15.10.2020**

Board had earlier advised the Zonal Railways that a Centralised Computer based objective type test shall be held for both 70% Selection and 30% LDCE for promotion to Group 'B' posts in all Organised Departments except for Accounts and IRPFS. The preparatory work in terms of finalization of syllabus, question bank and the agencies for taking examination is in progress. To ensure that no eligible candidate is deprived of the opportunity for promotion, Board have reviewed the matter and decided that as an interim measure, for vacancies arising in the panel year 2021 the earlier system of selection as advised vide Board's letter No.E(GP)2018/2/31 dated 19.3.2019 shall continue

2. Syllabus for the examination will be as follows:-
  - (a) Syllabus prepared by Railways will be used for 70% Selection for all posts except for the post of Group 'B' APO;
  - (b) Syllabus prepared and circulated by Railway Board for APO.

2.1 Syllabus for promotion to Group 'B' post of AMM (circulated vide Board's letter No.2020/RS(P)/6123/Group B Promotions (70%) dated 9.12.2020 and for AOM and ACM (circulated vide Board's letter No.2020/TT-I/76/Staff/2 dated 8.12.2020) stands withdrawn.

3. The action taken in the matter and the status of progress for selection shall be advised to the Board in the following format by the first week of February and thereafter on a monthly basis.
