M/s. Nova Construction, Nahar Road, opposite Durga Mandir Rustampur, Gorakhpur, Uttar Pradesh were served with a Memorandum and Statement of Imputation of misconduct for Banning of business dealing with them for having committed serious misconduct as found in preventive check, on the aspect of payment without actual execution of work.

In reference to the Memorandum and Statement of Imputations of misconduct, clarification of the firm and the views of North Eastern Railway(NER) were received vide NER's letter dated 06.08.2019. Based on facts available in the clarification, the competent authority on merits of the case, has considered the matter and it is established that M/s. Nova Construction, Gorakhpur is fully responsible for indulging in the malpractices by way of claiming fraudulent payment without actual execution of work. It has, therefore, been decided by the competent authority in the Ministry of Railways (Railway Board) that business dealing with M/s. Nova Construction, Nahar Road, opposite Durga Mandir Rustampur, Gorakhpur, Uttar Pradesh and also with their allied/sister concerns & partners should be banned on all Indian Railways including Project Organizations, Production Units and Railway PSUs etc. under the Ministry of Railways (Railway Board) for a period of five (5) years with immediate effect.
