Sub:- Grant of financial upgradation under MACPS to ASM-clarification reg.

Ref:- N.C.Rly's letter No.797-E/NCR/POLICY/CONTEXT/JHANSI DIVISION/2021,
dated 13.04.2021.

The matter referred vide N.C.Rly's letter dated 13.04.2021 has been examined in Board's Office. It is stated that Board's letters dated 25.02.2020(RBE No.26/2020) and 24.11.2020(RBE No. (99/2020) no where prescribes to treat Grade Pay of Rs.4200/ as entry grade for ASMs. It is further stated that based on 7th CPC recommendation the post of ASM (GP 2800) has been upgraded and merged with the post of SM (GP 4200) and implemented vide Board's letter dated 02.08.2016 (RBE No. 93/2016). This merger/ upgradation has to be ignored for the purpose of grant of financial upgradation under MACPS in terms of Board's letter dated 25.02.2020 & Board's letter dated 24.11.2020 . Evidently, these instructions apply to the cases where employee has progressed from ASM to SM. Therefore, ASMs who progressed to other cadres and did not get promoted from ASM to SM's post are not entitled to benefit of Board's aforementioned letters.
