ADVERTISEMENT FOR OUTSOURCING THE PATHOLOGY SERVICES FOR DIVISIONAL RAILWAY HOSPITAL, AGRA & HEALTH UNIT. MATHURA

CMS/North Central Railway/Agra is inviting applications from qualified Pathologists and running Laboratories Centers for outsourcing the investigations of Pathological. Willing Pathologist and Laboratories (NABL & Non-NABL) owner need to apply within 15 (Fifteen) days of publication of this ADVERTISEMENT

Following conditions are mandatory -

1. The Pathologist should have a well equipped & registered Laboratories (registered with Chief Medical Officer/District Agra/Mathura).
2. The rates of above investigation should be based on CGHS (Non-NABL) 2014 Meerut rates, which will be applicable for two years.
3. New diagnostic tests not-included in CGHS Meerut list 2014 may be done on discounted rate (Min. 30%) on lab-rates.
4. If the work given by the laboratory is satisfactory then only process of the next year extension will be considered & there will be no variation in the CGHS (NABL or Non-NABL) 2014 Meerut rates.
5. The Pathologist running laboratory will depute a well trained & well behaved Laboratory technician in DIVISIONAL Railway Hospital, Agra & Health Unit, Mathura To collect the samples of Blood, Urine, Stool etc. from (09:00 AM to 13.00 Hrs, daily) in emergency he will collect samples from the residence of seriously ill railway employees.
6. No payment will be charged from Railway Employees, their dependents & retired railway employees duly referred by authorized Railway Medical Officer.
7. The mode of payment will be done on bill system based on CGHS (Non-NABL) 2014 Meerut rates list.
8. All the disputes or differences will be resolved by Arbitrator deputed by G.M./NCR/Allahabad, the Arbitration Act (26) of 1996 will be applicable for this. If disagreed with the decision of the Arbitrator and appeal can be made to G.M./NCR/Allahabad & his decision will be accepted by both the parties, further disagreeing upon the matter can be taken to Agra District Court
9. All documents containing copy of registration certificate. Experience proving documents, CGHS (Non-NABL or NABL) 2014 Meerut rates list, with the signature of the Pathologist on every page in a sealed envelope should be deposited in the one the Chief Medical Superintendent/North Central Railway Agra Cantt (U.P.) 282001 during office hours from 10:00 AM to 5:00 PM on all working days.
10. Nearest laboratories will be given priority.
