

Please find enclosed herewith a copy of this Ministry's letter of even no. dated 19.06.2018 followed by a corrigendum dated 21.06.2018, regarding the above mentioned subject, enclosing the copy of Department of Personnel & Training (DOP&T)'s OM No. 36012/11/2016-Estt.(Res-1){Pt-11} dated 15.06.2018, wherein DOP&T had advised the Cadre controlling authorities of Central Government Ministries, Departments and Union Territories to carry out promotions in accordance with the directions of the Hon'ble Supreme Court orders dated 17.05.2018 and 05.06.2018 based on existing seniority/select lists. Further, it has also been mentioned that every promotion order must clearly mention the stipulation that the promotion shall be subject to further orders which may be passed by the Hon'ble Supreme Court.

The instructions contained in the DOP&T's OM dated 15.06.2018 is being reiterated once again for information/strict compliance bringing to the notice of all concerned.
