**Sub:** Recruitment Rule for the post of Public Prosecutor in Level-7 of 7<sup>th</sup> CPC Pay Matrix.

In regard to the Recruitment Rules for post of Public Prosecutor in Level-7, it has been decided to insert (XVI) Prosecution Cadre Para 178 B in Chapter-I, Section-B, Subsection-III- Recruitment and Training into Indian Railways Establishment Manual (IREM), Volume-I (Revised Edition 1989) first Re-Print Edition 2009 as per Advanced Correction Slip No. 275 enclosed.

2. It is also decided that all the officers holding the erstwhile posts of Sub-Inspector (Prosecution) in Level-6 of the pay matrix on regular basis not meeting the eligibility criteria for promotion to the next higher grade of Public Prosecutor which is five years regular service in Level-6 of pay matrix in the post of Sub-Inspector (Prosecution), may be allowed to continue in their present grade till the time the criteria is met.
