In continuation to this office letter of even number dated 02.08.2021, it is to inform that, as per applications received from Divisions/Workshop/Units of NCR, a provisional list of 30 (Thirty) eligible employees for selection to the post of ACM (Gr.-'B') against 30% quota vacancies for formation of 'Provisional Panel' for the assessment year 2021-23 in Commercial Department is enclosed as Annexure - 'I'.

If any employee found to be ineligible for selection to the post of ACM (Gr.-'B') at any stage, his/her candidature will be cancelled.

All the Divisions/Workshops/Units and all the branches of HQ are advised to ensure that the names of the employees whose applications were forwarded by them have been incorporated in the eligibility list. If changes are involved this may kindly be brought to the notice of this office through proper channel at the earliest.

Further, it is also advised that all the eligible SC employees are required to be given pre-selection coaching/training to be organized by the Branch Officers of Commercial Department of Divisions as per instructions contained in para 6 of notification dated 02.08.2021. The eligible SC candidates working in the Headquarters Office & NCRPU should be attached with Prayagraj Division and Construction Units should be attached with adjacent Divisions for pre-selection Coaching/Training. The competent authority has directed to start the pre selection coaching w.e.f 06.12.2021 and on completion of the coaching/training, a certificate to this effect must be sent to this office on prescribed proforma, already circulated earlier as Annexure - 'B' vide notification dated 02.08.2021.

The date of pre-qualifying examination is scheduled on 28.01.2022 (Friday). The venue & time of pre-qualifying examination will be intimated later on. All the employees enlisted in Annexure 'I' may be informed accordingly.


