1. In terms of provision contained in para 189(iii) of IREM vol.-1, 2009 Edition for promotion to Gr. 'C' post in ministerial cadre, all the selected erstwhile Group 'D' candidates will be required to pass typewriting test with prescribed speed in terms of extant instructions issued by railway from time to time. Therefore above empanelled staff will be required to qualify the prescribed typewriting test within 02 (Two) years time from the date of promotion as per laid down condition and if they fail to qualify the typewriting test within period they will be liable to be reverted to the original post.

2. The Promotion of the above staff shall be subject to further orders passed by Hon'ble Supreme Court in terms of instructions forwarded by Railway Board's letter No. 2016-E(SCT) I/25/8 dated 30.09.2016 & Railway Board's letter No. 2018-E(SCT)I/25/9 dated 19.06.2018.
3. The above select list is provisional subject to modification / final outcome of any court case pending before various Hon'ble Courts and new facts coming to the notice of administration later on.
4. The above candidates placed on provisional select list are advised that merely placement on the provisional panel no guarantee for retention of their names on the provisional panel which will depend on satisfactory service during the currency of the provisional panel.
5. Before making promotion of the above named employees on the basis of their empanelment, it must be ensured that they are free from D&AR cases. If any case is pending against them, it must be informed to the office immediately for taking necessary action.
6. The placement of name of the candidates on Provisional Panel shall be subject to further orders in Contempt Petition (C) No. 314 of 2016 in SLP (C) No. 4831/2012 and shall also depend upon the decisions in other pending SLPs before Hon'ble Supreme Court.
7. As further instructions from the Nodal ministry are awaited, all promotion orders should be on provisional basis stating that "these orders are provisional and are subject to the final outcome of ongoing litigations/court cases on the subject."
