

My dear General Manager,

Delegations of powers to GMs and its amendments are issued from time to time. A need was felt to make it more dynamic and convenient to use with a view to facilitate ease in decision making at all levels in Railways. In line with this thinking a comprehensive zero based review of Delegation of powers has been undertaken. As a result of this exercise, more delegation to General Managers along with consolidation of instructions has been done. The delegation of powers being issued has been simplified. In most of the items, source of instruction has been given for further reference.

Any further delegation by General Managers to field units can be done in consultation with PFAs.

I hope, this new Delegation of Powers would be helpful in dealing with the contemporary challenges of the Railways and would enable faster decisions to achieve organizational objectives. Any suggestions on further improvement are welcome.
