

Sub: Request for issue of Post Retirement Complimentary Pass (PRCP).

Ref: Representation dated 05.10.2021 of Shri Ram Babu Tiwari (Retd. Tech. I/Agra Division/NCR), received vide MR Office Dy. No.MR/C/1003804 dated 20.10.2021.

A copy of above cited representation, which is self-explanatory, is enclosed. Primarily it is seen that the Pass Issuing Authority (PIA) in the Division is demanding production of old Pass for issuing PRCP to the retired Railway Servant. As per extant Railway Servants (Pass) Rules, 1986 (Second Edition – 1993), there is no requirement for enclosing the old Pass for obtaining a new PRCP and PIAs are to maintain proper records and entitlement details of retired employees on their own. The Railway is, therefore, advised to take necessary action to expeditiously issue PRCP to the retired employee without insisting for old Pass. Action taken in the matter may be advised to the applicant, under intimation to this office.
