

Attention is invited to Para 2(iv) of Board's letter No. E(NG)I/2018/PM1/4 dated 14.12.2018 (RBE No.196 of 2018) which stipulates that Railway may conduct examination in Computer Based Test (CBT) mode or pen and paper depending on their preparedness.

Central Vigilance Commission in a recent case has observed as follows:

1. Existing instructions of conducting exams and selections through Computer Based Tests to be ensured for compliance.
2. The concept of a third party head examiner may be explored if computer based test cannot be conducted for any reason.

It is requested that your railway's comments on the preparedness for conducting CBTs for selections /LDCE /GDCE and other examinations and feasibility of nominating a third party examiner, in case CBT cannot be held, may please be furnished, to enable necessary action being taken on the CVC's observation.
