Sub: Extension of validity of period for engagement of Group-D Staff on contractual/outsourcing basis in RCT against vacant post of Peons/Safaiwalas.

Ref: RCT/PB letter No.RCT/DLI/Admn.Policy/2016 dated 30.03.2021, 06.04.2022 and 26.04.2022.

Please refer to your letters quoted under reference on the subject captioned above. The matter has been examined in Board's office in consultation with Associate Finance of this Ministry.

2. Board have approved the validity of extension of the engagement of Group 'D' Staff (18 Peons & 13 Safaiwalas) in Railway Claims Tribunal Benches against the vacant posts for these categories, for a period of five years (05 years) from 28.04.2022 or till the posts are filled by the Zonal Railways from regular railway employees, whichever is earlier, subject to approved terms and conditions as per Annexure-A. During this period, Railway Claims Tribunal/Principal Bench may take up with Zonal Railways for filling up these vacancies so that need for outsourced Peons/Safaiwalas beyond this period do not arise. The expenditure may be met within RCT Budget availability.
