With reference to above, the CBT/Written examination for filling up **06 (UR=04, SC=01, ST=01)** Group 'B' posts of AOM/ATM against 70% (PQ) for the **assessment period (01.01.2023-31.12.2024)** of Operating Department, NCR was conducted by NAIIR/BRC on **19.02.2023** and Supplementary exam held on **05.03.2023**. The list of the **7(Seven)** candidates who have been qualified in CBT/written examination is enclosed as Annexure -'A'.

1. Controlling Officers are requested to advise to the candidates enlisted in Annexure 'A' to be in readiness for attending viva-voce at short notice date of which will be intimated later on.
2. The candidates may be directed to undergo the prescribed standard of Medical examination for Group 'B' Gazetted (Technical) for Operating Department as AOM/ATM. The authority conducting the medical examination should clearly certify whether the candidate concern is "FIT" for Group 'B' Gazetted (Technical) for Operating Department as AOM/ATM or otherwise. Medical memo in original along with one photocopy duly attested may be sent to Gazetted Section (Confidential)/Personnel Department/NCR/HQ/PRYJ on or before **23.03.2023** positively.
3. Personnel Officers of the concerned units are advised to send ACR/APARs for the last 06 years (2017-2022 with year ending), current D&AR status and Service Records updated in all respect of the candidates enlisted in Annexure 'A' may be sent to Gazetted Section (Confidential)/ Personnel Department/NCR/HQ/PRYJ on or before **23.03.2023** positively. In case any of the APARs is not written/not available, the APARs for the preceding year may be sent alongwith the certificate of the non availability etc. It may also be ensured that date of promotions in Grade Rs. 9300-34800 (GP 4200 and 4600) is recorded in the service record.
4. GM/Vigilance is requested to kindly arrange to furnish current vigilance status of the candidates enlisted in Annexure 'A' to Gazetted Section (Confidential)/ Personnel Department/NCR/HQ/PRYJ on or before **23.03.2023** positively.

5. D&AR/Vigilance status also includes indicating whether any of the candidates is undergoing punishment in the D&AR/Vigilance case effecting such promotion or otherwise may be sent to Gazetted Section (Confidential)/ Personnel Department/NCR/HQ/PRYJ on or before **23.03.2023** positively.
6. The result is subject to final outcome of pending court case, in any Hon'ble court.
