

Sub: Revision of the rates of Cycle (Maintenance) Allowance: Implementation of Seventh Central Pay Commission's recommendations.

Consequent upon the decision taken by the Government on the recommendation of the 7th Central Pay Commission related to the above mentioned allowance and In-supersession of Board's letter No. F(E)I/2008/AL-7/2 dated 18.09.2008, the President is pleased to revise the rates of Cycle (Maintenance) Allowance from Rs. 90/- to Rs. 180/- per month under Rule 1606 of IREC (Vol.II)-2005 Edition and the provisions contained in Railway Ministry's decision below this rule.

2. The admissibility of Cycle (Maintenance) Allowance will be subject to the following conditions:

(A) The official concerned maintains and uses his own cycle for official journeys.

(B) Travelling Allowance (i.e. daily and mileage allowance) to a Government servant in receipt of Cycle (Maintenance) Allowance under these orders will be regulated as under:

(i) For journeys within a radius of 8 kilometres from the usual place of duty.	No T.A.
(ii) For journeys beyond a radius of 8 Kms. but not exceeding 16 Kms. from the place of duty.	
(a) If the destination point falls within the local jurisdiction.	No T.A.
(b) If the destination point falls outside the local jurisdiction.	T.A. admissible under normal rules provided the journey is performed otherwise than on a cycle.
(iii) For journeys beyond a radius of 16 Kms. from the usual place of duty	T.A. admissible under the normal rules

(C) The allowance will not be admissible for the calendar month(s) wholly covered by leave, training, or temporary transfer.

(D) For any period of more than one month at a time during which a Railway servant in receipt of Cycle (Maintenance) Allowance does not maintain a cycle or the cycle maintained by him remains out of order or is not used for official journeys for any other reason, the Cycle (Maintenance) Allowance will not be admissible.


3. The Cycle (Maintenance) Allowance under these orders shall be granted by the sanctioning authority for a period not exceeding two years at a time and its continuance shall be reviewed sufficiently in advance of the expiry of such period. The sanctioning authority

may, for this purpose, specify whenever necessary the local jurisdiction of a Railway servant at the time of sanctioning the allowance. They should also make a review of the posts under their control and decide the posts for which the Cycle (Maintenance) Allowance should be sanctioned. The Allowance may be sanctioned with reference to the posts and not to the individual Incumbents

4. **These orders shall take effect from 1st July, 2017.**







विषय: साइकिल (अनुरक्षण) भत्ता की दरों में संशोधन -- सातवें केन्द्रीय वेतन आयोग की सिफारिशों का क्रियान्वयन।

ऊपर उल्लिखित भत्ते के संबंध में सातवें केन्द्रीय वेतन आयोग की सिफारिशों पर सरकार द्वारा लिए गए निर्णय के परिणामस्वरूप और बोर्ड के दिनांक 18.09.2008 के पत्र सं. एफ(ई)/2008/एएल-7/2 का अधिक्रमण करते हुए राष्ट्रपति, आईआरईसी (वाल्यूम II)-2005 संस्करण के नियम 1606 और इस नियम के अंतर्गत रेल मंत्रालय के निर्णय में निहित प्रावधानों के तहत, साइकिल (अनुरक्षण) भत्ता की दरें 90 रुपए प्रतिमाह से संशोधित करके 180 रुपए प्रति माह करते हैं।

2. साइकिल (अनुरक्षण) भत्ते की स्वीकार्यता निम्नलिखित शर्तों के अनुसार होगी:

(क) संबंधित कर्मचारी अपनी साइकिल का अनुरक्षण एवं उपयोग सरकारी यात्रा के लिए करता हो।

(ख) इन आदेशों के अंतर्गत साइकिल (अनुरक्षण) भत्ता प्राप्त करने वाले सरकारी सेवक का यात्रा भत्ता (अर्थात् दैनिक एवं माइलेज भत्ता) को निम्नानुसार विनियमित किया जाएगा:

(i) ड्यूटी के सामान्य स्थान से 8 किलोमीटर की परिधि के भीतर यात्रा के लिए।	कोई यात्रा भत्ता नहीं
(ii) ड्यूटी के स्थान से 8 किलोमीटर की परिधि से बाहर परन्तु 16 किलोमीटर के भीतर।	
(क) यदि गंतव्य स्थल स्थानीय क्षेत्राधिकार में आता है।	कोई यात्रा भत्ता नहीं।
(ख) यदि गंतव्य स्थल स्थानीय क्षेत्राधिकार से बाहर आता है।	सामान्य नियमों के अंतर्गत स्वीकार्य यात्रा भत्ता बशर्ते कि यात्रा साइकिल के अलावा किसी अन्य माध्यम से पूरी की गई हो।
(iii) ड्यूटी के सामान्य स्थल से 16 किमी. की परिधि से बाहर यात्रा के लिए।	सामान्य नियमों के अंतर्गत स्वीकार्य यात्रा भत्ता।

(ग) उन कैलेण्डर माह के लिए भत्ता स्वीकार्य नहीं होगा जो पूर्णतः अवकाश, प्रशिक्षण या अस्थायी स्थानांतरण में व्यतीत हुए हों।

(घ) एक साथ एक माह से अधिक किसी अवधि जिसके दौरान कोई रेल सेवक जिसे साइकिल (अनुरक्षण) भत्ता प्राप्त हो रहा हो, साइकिल का अनुरक्षण नहीं करता है या उसके द्वारा अनुरक्षित साइकिल खराब हो या उसका उपयोग किसी अन्य कारण से, सरकारी यात्रा के लिए न किया गया हो तो साइकिल (अनुरक्षण) भत्ता स्वीकार्य नहीं होगा।

3. इन आदेशों के अंतर्गत साइकिल (अनुरक्षण) भत्ता स्वीकार्यकर्ता प्राधिकारी द्वारा एक बार में दो वर्ष से अधिक अवधि के लिए प्रदान नहीं किया जाएगा और उस अवधि के समाप्त होने से पर्याप्त समय पहले उसके जारी रहने की समीक्षा की जाएगी। स्वीकार्यकर्ता प्राधिकारी इस प्रयोजन के लिए जब कभी आवश्यक हो, भत्ता स्वीकार करने समय रेल सेवक का स्थानीय क्षेत्राधिकार निर्धारित कर सकता है। उन्हें अपने नियंत्रणाधीन पदों की समीक्षा भी करनी चाहिए और यह निर्णय करना चाहिए कि किन पदों के लिए साइकिल (अनुरक्षण) भत्ता स्वीकृत करना चाहिए। भत्ता पदों के संदर्भ में स्वीकृत किया जाए न कि व्यक्तिगत लाभार्थी के संदर्भ में।
