Sub: Policy Guidelines for concession in freight charges for Short Lead Traffic.

1. Sanction of the Competent Authority is hereby accorded for grant of concession in charging of freight for all traffic except "Coal & Coke, Iron Ore (contained in Commodity Group No.14.1 in IRCA Goods Tariff No.49 Pt.I Vol.II), Military Traffic, Rail Material Consignments (RMC) and Container Traffic" booked upto 100 KM as per the following:

Distance Slab	Freight Concession
0-50 KM	50% (Fifty percent)
51-75 KM	25% (Twenty five percent)
76-90 KM	10% (Ten percent)
91-100 KM	NIL

2. The applicable concession as mentioned above shall be given on Normal Tariff Rate (NTR).
3. No other concession shall be concurrently available with this policy except 6% concession on freight applicable to traffic booked to and from North East region.
4. These instructions will come into force with effect from 01.07.2020 and shall remain valid till 30.06.2021.
5. CRIS will carry out software modification for system implementation by 07.07.2020. Till then, the concession has to be implemented by Goods clerks while preparation of Railway Receipt with proper remarks. ZRs will depute CMIs to check the manual concession to prevent revenue leakage till CRIS develops system implementation.
6. This issue in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of the Ministry of Railways.





Sub : Policy Guidelines for concession in freight charges for Short Lead Traffic.

Ref : Rates Circular No. 16 of 2020 and corrigenda thereto.

1. Reference above, graded concession in charging of freight, for all traffic except Coal & Coke, Iron Ore, Military Traffic, Rail Material Consignments and Container Traffic booked up to 100 km, was granted in terms of Rates Circular No. 16 of 2020 w.e.f. 01.07.2020 till 30.06.2021; in terms of its corrigendum no.2 dated 30.06.2021 till 30.06.2022; and in terms of its Corrigendum no.3 dated 30.06.2022 extended up to 30.06.2023.
2. The matter has been reviewed and the Competent Authority has decided to extend the validity of Rate Circular No. 16 of 2020 for a further period of six months i.e. up to 31.12.2023.
3. All other terms and conditions laid down in above referred Rates Circular shall continue to apply unchanged.
4. All Zonal Railways please keep a watch on the subject traffic and arrange to provide comments enabling this office to review the subject concession.
5. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.


