In terms of Railway Board's letters under reference and with the approval of the Competent Authority, applications are invited from Interested and willing retired gazetted officers from all over Indian Railways (Junior Scale/Senior Scale/JAG) for re-engagement as Consultant in view of exigencies of services. Vacancies for re-engagement as Consultant are as under-

Construction Org./PRYJ	Consultant (Civil Engineering)	02	Retired Junior Scale/Senior Scale /JAG officer of Civil Engineering Department.

2. Interested and willing retired gazetted officers from all over Indian Railways (Junior Scale/Senior Scale/JAG) may apply for re-engagement as Consultant accepting the following terms & conditions:-

- The engagement of consultant shall not be considered as a case of re-employment.
- Maximum age limit of the re-engagement shall be 65 years.
- The period of engagement shall be initially for one year and further extendable as per requirement of the administration.
- While re-engaging such officers, medical fitness of the appropriate category shall be obtained from the designated authorities as per existing practices (as done in selection from Group 'C' to Group 'B').
- Re-engaged officer shall not be entitled for requisitions such as HRA, CCA. Transport Allowance, Residential accommodation etc. However, when required to travel in connection with official work, TA/DA admissible to regular employee working in the same Grade will be admissible.
- 12 days leave in a calendar year on pro-rata basis is admissible.
- The designation shall be consultant followed by (trade name) as indicated above.
- Re-engaged officer shall be discharged immediately on joining of selected candidate(s) (from UPSC or departmental selection or as per the recommendation of PHOD/CHOD concerned).
- Re-engaged officers shall be given responsibilities like inspections, supervision, drawing etc.

- j. The consultant shall not divulge any Information gathered by him/her during the period of assignment related to the organisation to anyone who is not authorised to know/have the same.
- k. They will not be made Incharge of the unit like Branch Officer in the Division or Independent incharge In the Construction Unit.
- l. Re-engagement officers shall not be given the financial and D&AR powers and shall not be authorised to issue any safety certificate
- m. Other terms and conditions Including the monthly remuneration of a retired Railway officer being re-engaged will be governed by Instructions contained in Railway Board's letters dated 25.10.2018, 20.12.2018 & dated 20.02.2023 under reference and further Instructions issued from time to time.

**3. How to apply:**

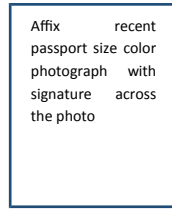
