In terms of Board's aforementioned letter, a Special Group 'B' selection drive has been notified for filling up the gazetted vacancies on the Railways. References have been received from a few Zonal Railways seeking clarifications on preparation of integrated seniority lists for certain Group 'C' cadres whose pay structures have since been upgraded in terms of Board's letter no. PC-VII/2019/RSRP/3 dt. 17.11.2022 (RBE No.155/2022).

In this connection, it is clarified that the aforesaid special drive for Group 'B' Selection is a part of Selection and LDCE notified and concluded earlier for the current vacancy cycle of 01.01.2023 to 31.12.2024.
