Statement of Charges/Misconduct

- 1. An open tender invited by the office Chief Administrative Officer (Construction), South Central Railway for execution of work i.e., "Doubling of track between Guntur Guntakal section Earthwork in formation including blanketing to GE:0014 specifications, construction of bridges, RUBS for LCS and other miscellaneous works including S&T obstructions from Km 5.00 to Km 60,00 between Nallapadu(including) and Santamaguluru (excluding) stations-Reach-1 with a value of Rs 1,03,81,85,701.01ps vide contract agreement No.66/CAO/C/SC/2017, Dt.30.11.2017.
- 2. A preventive check was conducted on 30.06.2018 for earthwork in embankment between Chainage 13850m to 14125m. The initial levels of Chainage 13900m, 13950m and 14000m were checked by opening the earth with JCB. The average area of three cross sections were worked out as 2.87 square meter and accordingly quantity from chainage 13850m to 14125m i.e., 275m was worked out to 789.25 cubic meter. However, as per record maintained in Measurement Book No.7147, the quantity recorded for COE and SQ2 from chainage 13850m to 14125m was 204.865 cubic meter and 1695.90 cubic meter respectively. Thus, the total excess quantity of COE and SQ2 recorded as was 204.865 cubic meter and 900.651 cubic metre respectively. Hence, the firm with malafide intention and in connivance with Railway officials got recorded wrong inflated levels in level register and fictitious measurements in Measurement Book which caused a loss of Rs.3,05,832.40 ps.
