One of the recommendations (Item no. 3.2 - Skilled Personnel)) given during Chintan Shivir-2023, held on 1st and 2nd June, 2023 at Manekshaw Centre, New Delhi was regarding introduction of Certification Courses (3 to 6 month) on Electrical/TRD by Railway Training centres to ensure availability of skilled supervisors for Project Supervision Services (PSS) and Project Management Services (PMS).

- 2. The matter has been considered in Board's Office and a 24 weeks course curriculum for Electrical and TRD for outsourced staff for PSS and PMS prepared by IRIEEN and approved by Additional Member/Railway Electrification (AM/RE) is enclosed herewith.
- 3. It may also be noted that since there is an over lapping in the duties carried out by Supervisors and Artisans (PSS & PMS), the curriculum have been kept same for PSS & PMS. Presentation, feedback, Group discussion and examination/Viva voce is to be conducted in the last week of the course and certificates are to be issued to the successful trainees. The knowledge of Electricity Act and Codes to be imparted is applicable to General electric works as well as TRD works in Railway. The Codes and Manuals applicable along with the methods of their applications will be imparted in the skill training. Training fees will be as per Railway Board Letter No. E (Trg) 2008 (22) 1-A dtd. 27.10.2023 (copy enclosed)


