

Vide reference (iii) above, approval of Board for draft Novation Agreement for novation of contracts for transfer of projects to the respective Zonal Railway/Production Unit was communicated earlier on 01.03.2024 for further implementation and necessary action by the parties.

Now, it has been decided to extend the timeline for completion of novation agreements between the parties and actual transfer of projects to the Railways after correct assessment of residual work from 31.03.2024 to D+90 days (where D is the day of approval of draft novation agreement by Railway Board).

Accordingly, it is advised that completion of novation agreements between the parties and transfer of projects from WPO to respective Railways may kindly be ensured by 30th May 2024.
