Personnel Officer of the concerned unit is advised to send ACR/APARs for the last 06 years (2017-2022 with year ending), current D&AR status and Service Records updated in all respect of the candidates may be sent to Gazetted Section (Confidential)/ Personnel Department/NCR/HQ/PRYJ on or before 16.04.2024 positively. In case any of the APARs is not written/not available, the APARs for the preceding year may be sent alongwith the certificate of the non availability etc. It may also be ensured that date of promotions in Grade Rs. 9300-34800 (GP 4200 and 4600) is recorded in the service record.
4. GM/Vigilance is requested to kindly arrange to furnish current vigilance status of the above candidate to Gazetted Section (Confidential)/ Personnel Department/NCR/HQ/PRYJ on or before 16.04.2024 positively.
5. D&AR/Vigilance status also includes indicating whether the candidate is undergoing punishment in the D&AR/Vigilance case effecting such promotion or otherwise may be sent to Gazetted Section (Confidential)/ Personnel Department/NCR/HQ/PRYJ on or before 16.04.2024 positively.
