However, their empanclment / appointment will be regulated as per procedure laid down in para 1(iii) of Board's instructions dated 07.02.2000 (copy enclosed for ready reference). Further, while issuing panels, restrictions imposed by Model Code of Conduct, as applicable, will be duly followed. Ministry of Railway would approach the Election Commission of India seeking permission to publish the results.

Sub:- Production of original educational/caste certificates at the time of interview/verification of certificates.

The matter regarding non-production of original educational/caste certificates at the time of interview/verification of certificates by the candidates has been considered and the Board have decided the following norms in this regard:-

- (i) No provisional or deficient caste certificates should be accepted, nor any extra time may be allowed for production of caste certificate. Candidates failing to produce original caste certificates at the time of interview/verification of certificates can be treated as belonging to un-reserved categories. They may be empanelled as general candidates if they qualify on general merit, otherwise not.
- (ii) As regards provisional certificates of educational qualifications, it is a fact that there is some delay from the Universities/examining bodies in issuing proper degree/certificates. However, they, invariably, issue a final mark sheet well in time. Therefore, if the candidate fails to produce even a final mark sheet at the time of verification, his candidature should be rejected.
- (iii) If the candidate produces a final marks sheet, and gives an undertaking that the degree/certificate is yet to be issued, he may be empanelled provisionally, but the indenter should be advised that the candidate should not be offered appointment unless he produces his original degree/certificate, or it is verified from the concerned university/examining body, that he has indeed passed the examination for which the marks sheet has been submitted by him.

(iv) In unusual cases such as theft of certificates while proceeding to RRB, the Chairman may, at his discretion, allow time to such candidates, stipulating a fixed period, mot exceeding two months.

(This disposes of Chairman/RRB/Chandigarh's reference No.RRB/CDG/RP-1/99 of May 1999 on the subject.)

These instructions should be complied with strictly.
