- 2) The ex-cadre Group "B" post of Protocol Officer shall be filled up on the basis of Viva-Voce and assessment of APARs.
- 3) The interview will mainly comprise of assessment of personality and knowledge about Indian Railways and the setup of various organizations under central and State Governments, There PSUs, Protocol matters and others allied matters which are expected to be in the knowledge of a person aspiring to become a Protocol Officer in Railways.
- 4) The tenure on ex-cadre Group "B" post of Protocol Officer shall normally not exceed four years. The lien of the selected incumbents will continue to be maintained in their respective non- gazetted/gazetted cadre. Further they will earn regular promotions in their respective cadres as per the Rules etc. governing the said posts. After completion of 04 years incumbent will be repatriated to his parent cadre.

- 5) In case a Group "C" employee is selected to the ex-cadre Group "B" post of Protocol Officer, he should be repatriated to his parent cadre at least one year before the date of his retirement on superannuation, irrespective of his tenure. Also, his settlement dues on retirement will be made accordingly as per the lien held by him on his respective non-gazetted cadre.
- 6) This circular may also be notified to the staff who are working outside of NCR on deputation basis, but having lien in North Central Railway. The controlling officers and the establishment officers concerned will please ensure notification of this circular to such staff.
- 7) Candidates who fulfil eligibility criteria will be required to undergo medical examination as per IRMM-I, Chapter-V and candidates who qualify in the medical examination will be called for viva-voce.
- 8) The staff willing to be considered for the selection may apply in the proforma enclosed as Annexure-I.
- 9) The application on the proforma (Annexure-1) duly filed in all respect should be submitted through their respective controlling officers, so as to reach this office by 30.05.2024
- 10) Application received after the last will not be considered.
