The candidates may be spared well in time for the vivo-voce test and directed to report in
Gazetted Section/Personnel Department/NCR/HQ/PRYJ on 29.05.2024 (Wednesday) at 15:00
Hrs sharp.

As per instructions contained in Railway Board's letter No. E(GP) 80/2/8 dated
31.10.1991 , the names of the candidates who do not pass the prescribed medical standard
should not be included in the panel. Accordingly, only those who qualified in the medical
examination of prescribed standard should be called for viva voce.

Based on the above facts and Railway Board's letter No. E(GP) 80/2/8 dated
31.10.1991, Shri Prakash Chand Meena, CBS/ETW/PRYJ who has not passed the

prescribed medical standard (Group 'B' technical), hence, not eligible for viva voce test of ACM.

Accordingly, viva voce test of rest 07 employees are to be conducted for ACM, special drive against 70% quota for Commercial Department as per list of candidates enlisted as Annexure 'A' is enclosed herewith
