NOTIFICATION

Sub:- Formation of panel for filling up the post of JE/Signal in Level-6 (7thCPC) against 40% Promotional quota of JE-Signal Cadre.

It is hereby proposed to form a panel for filling up of 11 vacancies of JE/Signal in Level-6 against 40% Promotional Quota in Signal Cadre of S&T Department, Prayagraj Division. The break-up of vacancies are as detailed below:-

1. Eligibility and Service conditions of Staff: -

The list of senior most eligible staff as per seniority list working as Sr.Technician/Signal in level-6 (as per extant provisions of RBE No. 21/2014) who are in the normal zone of consideration in the ratio of 1:3 as per their seniority is enclosed as **Annexure-I**. A provisional integrated seniority list of eligible employees of S&T Department/PRYJ, who are eligible to appear in the selection is enclosed as **Annexure 'I' (Main List)** and Reserve List as (**Annexure 'II'**). The employees in the Reserve List (**Annexure II**) may please note that they will be considered only to the extent of number of employees from the Annexure-I expressing unwillingness to appear in the said selection. Eligible and willing employees (**Annexure 'I' & 'II'**) must submit their application duly forwarded by their immediate supervisor/officer through proper channel to the Personnel Department clearly indicating willingness/unwillingness to appear in the selection on or before 25.06.2024. Applications received after 25.06.2024 will not be entertained and summarily rejected. If no application is received by any of the office/unit concerned, a certificate should be given to the Personnel department/PRYJ by unit concerned that no application has been received in their office:

- (i) On being selected employee should be prepared to work anywhere in Prayagraj Division.
- (ii) Submission of willingness does not confer any right on employee to appear in the said exam and it will be subject to the various conditions mentioned in this notification and relevant rules issued by Railway Board from time to time.
- (iii) Further, employee's promotion in JE/Signal is subject to their being fit in A-3 Medical Classification & passing prescribed training course.
The above is strictly based on integrated seniority list enclosed herewith as Annexure I (Main List) & Annexure II (Reserve List).

2. Mode of Selection:-

In terms of Railway Board's letter no. E (NG) 1/2000/PM1/41, dated 07-08-2003, the positive act of selection to assess the professional ability of the candidate shall consist of written test only. The candidates have to obtain a minimum of 60% marks in professional ability, i.e. in written examination, for being considered for further selection process of perusal of services record and APARs.

The post of Junior Engineer/Signal being classified as "Safety Category Post", there is no relaxation in qualifying marks to employees belonging to the categories of SC or ST, hence, they are also required to secure 60% marks in the written examination, however they shall be imparted 'Pre-Selection Coaching' as per extant rules.

3. The Syllabus prescribed for selection to the post of JE/Signal against 40% Promotional Quota is enclosed as 'Annexure-III'.

4. Procedure for written examination: -

- (i) In terms of railway Board letter no. E (NG) 1/2018/PM1/4 Dated 14.12.2018, 14.06.2019 and 14.11.2019, the written examination shall consist of 100% objective multiple choice questions.
- (ii) There will be no negative marking in selection against departmental quota where panel is arranged in the order of seniority from those qualified.
- (iii) Examination will be conducted on CBT (Computer Based Test) mode.

5. Date of Examination: -

As per letter issued by Chairman/RRC/PRYJ vide their letter No. RRC/NCR/PRYJ/Departmental CBT/Misc. dated 24.05.2024, the date of written examination has been fixed on 29.07.2024 and venue of written exam will be intimated separately. It is to be advised to the employees listed in Annexure-I & II that they should be in readiness to appear for the examination. Final eligibility list will be issued later.

6. Supplementary Examination: -

A Supplementary examination may be held only for those employees who have remained absent themselves from the main examination only in the following circumstances with the approval of competent authority.

- (i) Administration's failure to relieve the employee in time to appear in the written examination/late intimation of the date of test etc.
- (ii) Sickness of the candidate or other reason over which the employee has no control. Unavoidable absence will not, however, include absence to attend wedding or similar function or absence over which he/she has control. Sickness should be certified by Railway Medical officer.

7. Procedure for drawl of Panel:-

The names of the selected candidates will be arranged in the order or seniority but those securing a total of 80% or more marks in the aggregate will be classified as "outstanding" and placed in the panel appropriately in order of their seniority allowing them to supersede not more than 50% of total employees is the zone of consideration.

8. Pre selection coaching:-

In terms of instructions contained in railway Board's Lr.No.88-(SCT)/42/2, dated 8/11.01.1991., Pre selection/Pre promotion training to the SC/ST employees, is to be conducted covering the syllabus of the examination for selection to safety category post and will be imparted for a period of 3 to 4 weeks. After completion of the pre- selection coaching, a certificate has to be issued by the controlling officer to the effect that all the eligible SC/ST employees have been imparted Pre-selection coaching for a period of 3 to 4 weeks covering the syllabus prescribed for the examination. In case if any employee has expressed his unwillingness for pre-selection coaching, a written declaration to this effect must be obtained and forwarded to this office for record.

9. In terms of Railway Board instructions, the Senior Subordinate/Supervisor Concerned has to furnish a certificate that the eligible candidates were duly notified of the test and asked to submit their applications duly giving their willingness/unwillingness by each employee and forward the same to Sr.DPO/PRYJ. The willingness/unwillingness must be submitted in the office of Sr.DPO/PRYJ through Sr.DSTE/Co./PRYJ on or before 26-06-2024.
10. No willingness/unwillingness shall be accepted directly in the office of Sr.DPO/PRYJ. It should be the personal responsibility of the senior Subordinate/Supervisor to complete the formality in this respect. It is further advised that any other communication received in respect of the selection should invariably be intimated to all the eligible employees. Any laxity in this regard will be viewed seriously.
11. In case a candidate is found ineligible for the above selection at any stage, his/her candidature will be summarily rejected.
