The powers of field units to sanction itemised works under Umbrella Work/Lump sum, under various Planheads, were revised in the Board's letter under reference. A doubt has now been raised in respect of the powers to sanction works related to Institutes, Officers club, Rest Houses and Holiday Homes.

Though these works are related to the welfare of staff, the Umbrella Works for these activities have been sanctioned under PH 64 (OSW).

It is clarified that the powers have been specifically delegated for these works upto Rs. 2.5 crore, vide the letter under reference. Therefore, these activities can be sanctioned by the General managers upto Rs. 2.5 crore in each case, irrespective of the Planheads.
