As per instructions contained in Para 2(ii) of Railway Board's letter dated 28.08.2019, Pre-selection training is not required, if there is no reserved vacancy and candidates are appearing in the Selections/LDCEs against unreserved vacancies. As there is no reserved vacancy in A.Ph.O. selection, therefore, pre-selection coaching of reserved category candidate is not required.

All employees enlisted in Annexure 'A' may be directed to report in Personnel Branch, HQ office, Subedarganj, Prayagraj on **02.08.2024 at 10.00 Hrs.** with Identity Slip enclosed herewith as **ANNEXURE 'B'**. **Employees reporting without Identity Slip -Cum-Declaration will not be allowed to take part in the written examination.**

Please ensure that acknowledgement is obtained from individual employee well in advance and the information about written examination is communicated to them.


If any employee is found to be ineligible for selection to the post of A.Ph.O. (Gr. 'B') at any stage in future, his/her candidature will be cancelled.

All controlling officers, Sr.DPOs, Dy.CPOs, SPOs & APOs may personally ensure displaying of the notification in the prominent notice boards of the respective offices of HQ/Divisions/Workshops/Units. All the candidates enlisted in **Annexure 'A'** may be informed accordingly.

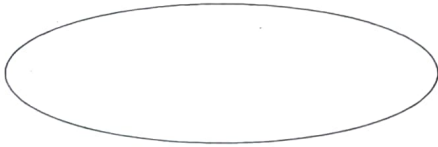
