Compliance of the directions of Hon'ble High Court of Delhi in Writ Petition (Civil) No. 520/2020 titled 'Mukesh Kumar vs. UOI & Ors'.-Form of Undertaking to be furnished by Armed Forces personnel for applying to Civil Posts under Ex-Servicemen category.

The undersigned is directed to say that the Ex-servicemen (Re-employment in Central Civil Services and Posts) Rules, 1979 has been amended from time to time. The Notification No.36034/1/2006-Estt.(Res.), dated 04.10.2012, defines the term 'Exservicemen' and includes other instructions with respect to the reservation for Exservicemen in civil posts and services of the Central Government. The definition of Exservicemen was further amended *vide* Notification No.36034/1/2019-Estt.(Res.), dated 13.02.2020 in respect of Short Service Commissioned Officers.

- 2. In compliance with the directions of Hon'ble High Court of Delhi in Writ Petition (Civil) No. 520/2020 titled 'Mukesh Kumar vs. UOI & Ors.' and after consultation with Department of Ex-servicemen Welfare, Department of Legal Affairs and other Ministries/Departments/Recruiting Agencies concerned, the appendix of DoPT O.M No. 36034/2/91-Estt(SCT), dated 3.04.1991, has been amended. The proforma of the certificate to be submitted along with the application form is at Annexure-1.
- 3. Candidate working in Armed Forces would become eligible for applying civil posts only when he completes the prescribed period of Armed Forces Service within a year from the last date for receiving application in connection with Special Recruitment/Examination, etc., prescribed by the Competent Authority.

Provided, when selection process takes more than one year, from the last date of receiving of applications, the candidate will not be declared ineligible under Exservicemen category only on the ground that he has got himself released from Armed Forces after one year from the last date of receiving of application.

4. Since the appointment of such a candidate is subject to the submission of documentary evidence that he/she has been duly released/retired/discharged from the Armed Forces and qualified as an Ex-Serviceman in terms of the rules/notifications ibid, such a candidate shall be required to submit along with his/her application an undertaking duly signed by him/her in the format enclosed, as Annexure-2/
