One of the Zonal Railways has sought clarification on the applicability of the age relaxation extended vide Board's letter dated 15.07.2024 (RBE No.63/2024) in direct recruitment from open market to the posts to be notified in 2024-25 for the recruitment under Scout and Guide Quota notified in the year 2024-25.

2. The matter has been examined and it is clarified that the age relaxation provided vide Board's letter (RBE No.63/2024) is applicable to open market recruitments to be notified by RRB/RRC for the first time during calendar year 2024, after Covid pandemic.
