

GENERAL NOTES FOR TENDER COMMITTEE:-

The third member of equal Grade as of executive member shall be from Sister Department and in the event of an officer of required Grade is not available in Sister Department, then third member may be nominated from other department(s) which deals with tenders, by DRM in division and General Manager in HQ.

- 2. (i) The level of TC will be decided by the post of executive, i.e., Convener. If post of executive member as mentioned against tender value is not in operation, the executive member will be of one step higher but other members will be of the same status as mentioned against tender value.
 - (ii) Similarly, if grade as mentioned against the tender value for other department i.e. Sister department or Accounts department is not in operation then member of other department i.e. Sister department or Accounts department will be one step higher and executive member i.e. convener shall be at least of the same status as of other department.
 - (iii) Accepting authority will be one grade higher than executive member i.e. convener
 - (iv) In all those cases of SAG level Tender Committee where SAG Member is not available, GM should either post a SAG officer of that department or should nominate a SAG officer of concerned department from open line/other unit for TC. (Authority: RB letter no. 2015/CE-I/CT/0/20/1 dated 11.11.2022)
- 3. In single packet tendering system, level of the tender committee shall be decided by the cost quoted by the valid lowest tenderer.
- In case of two packet system of tendering-
- (i) For Packet-I (Technical Bid evaluation), the level of TC to be decided by advertised tender value (NIT Value).
- (ii) For Packet-II (Financial Bid evaluation), the level of TC to be decided on the cost quoted by the lowest tenderer.
- (iii) In case of Reverse Auction(e-RA), the level of TC to consider the Final Price Offers shall be determined on the basis of lowest initial price of bid qualified for award of contract, as opened prior to Reverse auction.(Authority: Railway board letter No. 2017/Trans/01/Policy/Pt-S, dated 28.03.2018).
- (iv) In case technical bid is evaluated by specified grade of TC members and financial offer of L1 is of amount such that TC level is of lower one, then in this case TC will be done by the committee who did technical evaluation.
- For passenger amenity works at Divisional and Head Quarter level, besides the technical 5. and Finance members, the third member should invariably be from Commercial department. (Authority: Railway Board's letter no. 2007/TGIV/ 10/PA/Works dated 25.05.2007).
