RPF Security 1.

During the last two elections held in 2007 & 2013, security was provided for the Secret Ballot Election by RPF/RPSF forces. RPF departments deployed RPF/RPSF team for various activities such as polling, storage, transportation, counting, etc. The RPF Dte in Railway Board had issued a letter No.2011/Sec(Spl)/100/12 dated 15.03.2013 during the election held in 2013 to their Zonal Railways security department heads for doing the needful. Same process may be followed this year too for which necessary reference may be made to them.

CCTV Installation

During the course of consultation held with the stakeholders namely the contesting Unions and Railway authorities in the field, a common demand made was for installing CCTV camera at all the vantage locations such as the polling booths, storage room for Ballot Boxes and counting centres. Since the facility for installation of CCTV cameras with recording facility is now easily available at all places, the SBEC is proposing to make installation of this facility at all vantage points during the SBE- III. This shall be a new facility for which additional funds need to be made available under the onetime Imprest, which is provided to the ROs and Presiding Officers.
