It is proposed to conduct a selection to the post of Technician Gr.III/Sig. in Level-2 against 25% LDCE quota from amongst volunteering Assistant/S&T staff of S&T Department of Prayagraj Division as per the following terms and conditions.

(I) Details of Vacancies:-

(II) Eligibility conditions:-

1. Service Condition:-

As per instructions mentioned vide RBE No. 52/2024 Dated 14-06-2024, Assistant/S&T should have completed at least three years of service as on date of issue of notification i.e. **on 04.10-2024**.

2. Educational Qualification:-

(a) Matriculation (i.e.10th Pass) and ITI Certificate in Electronics Mechanic/Electrical fitter/Wireman Trade

OR

(b) Pass in Plus Two stage i.e. 12th Pass with Physics and Maths in Higher Secondary or equivalent.

3. Age:-

Should not be more than 45 years for General candidates and should not be more than 50 years for SC/ST candidates as on date of issue of notification i.e. **04.10-2024**.

4. Medical Classification:-

The prescribed medical classification for the safety post of Technician Gr.III/Sig. is BEE ONE (B1).

(III) Pre-selection Coaching:-

In terms of instructions contained in railway Board's Lr.No.88-(SCT)I/42/2, dated 8/11.01.1991., Pre selection/Pre promotion training to the SC/ST employees is to be conducted covering the syllabus of the examination for selection to safety category post and will be imparted for a period of 3 to 4 weeks. After completion of the pre- selection coaching, a certificate has to be issued by the controlling officer to the effect that all the eligible SC/ST employees have been imparted Pre- selection coaching for a period of 3 to 4 weeks covering the syllabus prescribed for the examination. In case if any employee has expressed his unwillingness for pre-selection coaching a written declaration to this effect must be obtained and forwarded to this office for records.

(IV) Syllabus:-

The syllabus for selection to the post of Technician Gr.III/Sig. in Level-2 is enclosed as **Annexure II.**

(V) Selection Criteria:-

1. The selection will consist of Written Examination and Assessment of Records of service and will be done as under:
 - (i) The Written examination will consist of 100% objective type questions. There will be 110 multiple choice questions (including 10 questions on Official Language/Rajbhasha Policy) against which any 100 questions are to be attended.
 - (ii) **There will be negative marks for every wrong answer @ 1/3 of allotted marks as per RBE No. 194/2019 dated 14.11.2019.**
 - (iii) The duration of the examination will be 120 minutes.
 - (iv) **There will be NO supplementary examination.**
2. **Procedure for empanelment:-**
 - (a) Candidates must secure a minimum of 60% marks in Professional Ability and 60% marks in the aggregate to be considered for empanelment in the order of merit.
 - (b) There will be no classification of candidates as 'Outstanding'.

- (VI)** Employees who have applied for selection should produce attested copies of certificates, in support of their academic and technical qualifications. Employees belonging to SC/ST community should produce attested copy of their community certificate also.


(VII) Last date for submission of application:

The willing and eligible volunteers has to submit their applications in prescribed pro-forma (**Annexure-I**) to their **controlling supervisors on or before 29.10.2024** who will forward the in one bunch with a covering letter, to the **controlling officer on before 04.11.2024**. The controlling officer has to forward all the applications in one bunch to **Sr.DPO/Prayagraj together with D&AR/SPE/Vig. clearance on or before 08.11.2024**. The candidate should necessarily fill all the relevant columns and strike out the inapplicable columns indicating as "NA". All the column of date should invariably filled in. The Supervisor shall also affix their Signature & date while forwarding application to the controlling officer. It should also be intimated to all concerned that no application will be entertained directly sent in this office.


