The notification for selection to fill up 01 post of Principal/NCRIC/TDL (Group 'B') in PB-III Rs. 15600-39100 + GP 5400 (Level-10) issued vide this office letter of even number dated 17.08.2023 is hereby cancelled.

Keeping in view of the eligibility criteria conveyed by Railway Board vide letter No. 2023/E(G)RR/17/1 dated 07.02.2024 referred above, it is proposed to hold the selection of assessment period 01.03.2014 to 29.02.2016, 01.03.2016 to 28.02.2018, 01.03.2018 to 29.02.2020, 01.03.2020 to 28.02.2022, 01.03.2022 to 29.02.2024 and 01.03.2024 to 28.02.2026. Only 01 vacancy is available for the assessment period 01.03.2022 to 29.02.2024 and there is NIL vacancy for rest of the assessment periods.

The selection will comprise of viva-voce test as per instructions contained in Railway Board's letter No E(GP)72/4/15 dated 27.05.1976. Further, as per guidelines provided by Railway Board vide letter dated 07.02.2024, to go ahead for the selection willingness/unwillingness from **01 eligible candidate (PGT)** were called vide this office letter of even number dated 27.09.2024. On the basis of the willingness received, candidate is found eligible to appear in the Selection for 01 Gr. 'B' post of Principal/NCRIC/TDL. In terms of Railway Board's extant instructions all the candidates who are eligible to appear in the viva-voce test are required to pass the prescribed medical test. It may clearly be mentioned in the medical memo that the eligible employee is to be examined medically for Gr. 'B' service (Non-technical).

The candidate appearing in **annexure 'A'** may be informed and directed for medical examination for non-technical Group 'B' post and the medical report may be sent to this office at the earliest. <u>The medical certificate must indicate the fitness by the medical authorities as under:</u>

"That I consider him/her fit for service in Gazetted Group 'B' post not connected with train working or use of trolley on open line (non-technical post)".

Unfitness should also be indicated in the same manner.
