


**Sub: Appointment of Central Observer for Secret Ballot Election-III.**

As you are aware, in terms of Railway Board's Letter No.ERB-1/2023/23/60 dated 17.11.2023, Secret Ballot Election for recognition of Trade Unions has been notified vide this Office letter No. 2024/SBEC-III/Elections dated 30.08.2024 & 09.09.2024.

2. As per Section 16.11 of the Final Modalities dated 09.09.2024, it has been decided to appoint Central Observer in the rank of HAG/NFHAG/SAG for the Zonal Railways/PUs concerned.

I, Rajiv Kishore appoint you as Central Observer for NCR, Prayagraj on the recommendations of General Manager NCR, Prayagraj. The overall role and function of Central Observer as visualized by Secret Ballot Election Committee are as under:-

- i. The Central Observer shall report to the SBEC.
- ii. She/he shall give independent inputs to the Returning Officer in taking corrective actions if required.
- iii. The Central Observer shall not have any executive function and shall not interfere with the election process being conducted by the Returning Officer/ Presiding Officer. However, she/he may receive complaints and forward the same to the Returning Officer with necessary inputs. The Returning Officer shall have the Central Observer properly briefed regarding the election schedule and processes so that the latter can take an informed view.
- iv. The tenure of the Central Observer will be co-terminus with the period of Secret Ballot Election-III.
