1. It has been decided to conduct selection for promotion to Group "B" post of Assistant Financial Advisor/Assistant Divisional Financial Manager, Level-9 (Rs. 53100-167800) 7th CPC in Accounts department through -70% (Quota) Selection and 30% LDCE. The break-up of vacancies assessed for the vacancy cycle 01/01/2025 to 31/12/2026 (including vacancies upto 30/06/2027) through centralized CBT:-

Note- In terms of Railway Board Letter RBE 97/2022 dt: 18/08/2022,14/11/2022 & 13/03/2023 and DOP&T'S OM dt: 17/05/2022, 01 vacancy is earmarked for the persons with Benchmark disabilities (PwBDs).

2. Eligibility:

In terms of Railway Board letter no. E(GP)2019/2/25 dated 27.12.2019 (RBE No 216/2019) and Para 6 of Master Circular 68 and Railway Board letter no. E(GP)2024/2/28 dated 08.10.2024 (RBE No 93/2024), the following Group C employees having lien in NCR fulfilling the required conditions as on 01.01.2025 are eligible to appear in the Selection:

- a. Group "C" employee working in Level-6 and above in Pay Matrix with 03 years of non-fortuitous service in Level-6 and above in Pay Matrix.
- b. Employee should have qualified in the Appendix-III (IREM) Examination.
- c. For PwBD candidates, medical certificate is necessary which is to be enclosed with Application Performa (Annexure-I)
- The service rendered by Group C staff in GP 4200/- (VI CPC)/Level 6 of Pay Matrix (VII PC) in MACP grade will not be considered for reckoning the period of service.
- ➤ The above selection will be held in terms of Railway Board's letter No. E(GP)2024/2/28 dt:08/10/2024 (RBE 93/2024) and in modification of provisions of Para 203.4 of IREM Vol.1, it has been decided by Board that henceforth, in respect of selections (70%) to Group-B posts in Accounts Departments, all employees who are eligible and who volunteer for the selection, should be considered without any limitation of number, as is being done in case of Selection to the Group-B post of Assistant Personnel Officer.
- 3. There will be pre selection training to eligible volunteers belonging to SC/ST community. The details of the pre-selection training will be notified in due course after finalization of the list of eligible volunteers for the selection.
- 4. The panel formed from this selection will be provisional subject to outcome of judgments of Hon'ble High Court / Supreme Court of India on reservation matters.

- Note:- 1. There shall be no negative marking for incorrect answers in written examinations held as part of Selections (70%) where final panels are made on seniority basis. (Authority: Railway Board's L.No. E(GP)2024/2/28 dt: 08/10/2024, RBE 93/2024)
 - 2. Duration of the exam will be two hours.
 - 3. The CBT shall be conducted by DG/NAIR Vadodara.
- 7. The question paper will be bilingual i.e. Hindi and English as per extant instructions. Candidates have the option to give answers in Hindi or English in CBT as well as in viva-voce.

- 8. The marks prescribed for qualifying in the written examination is 60%. Such passed candidates will be directed for medical examination for Gr. B category as per IRMM Para 530(b). On passing in the prescribed medical examination, such candidates will be called for viva-voce test. The marks of record of service would be given on the basis of Board's instructions contained in the updated Master circular no.-68.
- 9. The CBT examination for 70% (Quota) Regular selection will be held as per schedule below:-

Main Examination	9 th March, 2025
Supplementary Examination	23 rd March, 2025

- 10. Supplementary Examination will be held, if required, for the employees who fail to appear in the regular exam due to any of the following reasons:
 - a. Candidates not relieved on account of administrative reasons, which is to be certified by the Branch Officer in charge.
 - b. Candidates on medical/ sick leave to be certified by the Railway doctor only.
- 11. The syllabus for the CBT examination is as prescribed by Railway Board vide letter No. E(GP)/2022/2/4 dt:07/12/2022 is enclosed as Annexure-II to this notification. Any change in syllabus of the examination as advised by Railway Board/ NAIR will be communicated accordingly.
- 12. Interse seniority of all eligible candidates belonging to all cadres of Accounts Department of all units will be circulated in due course.
- 13. The programme for conducting 30% LDCE will be intimated as per programme of Railway Board/NAIR.
- 14. Divisions/Units are requested to give wide publicity to this notification by circulating and pasting them on notice boards.
- 15. Processing of all applications and related correspondence is to be done on e-office
- 16. In case of candidates who are on deputation, leave, training or working in Ex-cadre organization (if any), intimation to them should be ensured by the office/unit from where the candidate concerned proceeded on such deputation, leave etc..
- 17. The above Scheme of 70% Selection is provisional and changes, if any, will be notified according to subsequent guidelines issued by Railway Board/ NAIR.
