



Railway Board vide letter dated 03.02.2025 referred above have communicated the certain changes about calling the candidates for viva-voce and assessment of records of service i.e. to the extent of 6 times the number of vacancies (category-wise) in the order of seniority of those qualified in CBT against 70% selection (2025-26).


In view of the above, it is requested to kindly arrange to update the service records in all respect (promotion of employee in each stages) of all those candidates whose eligibility list has already been issued/circulated for appearing in written test (CBT) against 70% selection (2025-26) by this office to the post of AEN, AME, AEE, AMM, ASTE, ACM & AOM in order to avoid delay/inconvenience for preparing the seniority for the purpose at the time of declaration of result/Panel. However, in case of APO, the existing procedure of calling of candidates to the extent of 06 times the number of vacancies (category-wise) for Viva-Voce and assessment of Record of Service in the order of merit shall continue.

Apart from this, APARs of all eligible candidates must be completed and kept in readiness.

In terms of Board's letter under reference, it was decided that for 70% Selections to Group 'B' posts in all Departments having Organized Services, all employees who are eligible and who volunteer for the Selection, should be considered without any limitation of number, as in the case of APO.

2. In continuation to the said instructions, it has been decided by Board that in the case of Group 'B' posts other than APO, the candidates for *Viva Voce* and assessment of Record of Service shall be called to the extent of 06 times the number of vacancies (category-wise) in the order of seniority. In case of APO, the existing procedure of calling candidates to the extent of 06 times the number of vacancies (category-wise) for *Viva Voce* and assessment of Record of Service in the order of merit shall continue.

3. Further, it has been decided to do away with the grading of candidates as 'Good' / 'Outstanding' and subsequent supersession (as contained in paras 204.8 and 204.9 of IREM Vol. I, Revised Edition 1989) in 70% Selections across all Organized Departments. The panels will be formed in the order of seniority.

4. These instructions should be widely circulated.


NAIR/Vadodara vide Para 2 of their letter dated 12.02.2025 referred above has conveyed as under:
