SUB: Decision to change the category of schools run by the society created by the different Ministry / Department / Govt. Body / Undertaking - reg.


Sir,

You are aware that as per rule 3.1 under chapter - II of Affiliation Bye-Laws, the Board affiliates several categories of school all over India and Abroad, as for example:-

- (i) Government or Government aided schools;
- (ii) Schools run by autonomous Organisations under the Government like Kendriya Vidyalaya Sangathan (KVS), Navodaya Vidyalaya Samiti (NVS), Central Tibetan Schools Organisation (CTSO), Sainik Schools Society etc.
- (iii) Schools run by Government Department directly like Defence, Railways etc.
- (iv) Schools managed directly by Public Sector Undertakings or by reputed societies for Public Sector Undertakings under the financial control of such Public Sector Undertakings or by Societies formed by such undertakings.
- (v) Private, unaided schools established by societies registered under the societies Registration act, 1860 of the Government of India or under Acts of the State Governments as educational, charitable or religious societies having non-proprietary character with certain condition.

As of now, Sainik Schools, Rashtriya School, Army Schools /Army Public Schools, Naval Schools /Naval Public Schools, Air force Schools and schools run by different Ministries / Departments directly or indirectly by creating their own societies have been put under the Independent category of school considering that these schools are run by Ministries / Departments / Undertakings other than Education Department of Central / State / U.T Govt. resulting to non admissibility of certain relaxation / benefits which are available to Govt. / Govt. aided schools.

Of late, the Board has consider this issue in its affiliation committee Meeting held on 24.05.2012 and it was resolved that all such schools which are being run by the different Ministry / Department / Govt Organisation / Undertakings directly or indirectly by creating their own societies may henceforth be put under Govt / Govt. aided / school category. The above said decision of the affiliation committee had further been ratified by the Governing Body of the Board in its meeting held on 04.06.2012.

Therefore, in the light of the above decision, I am directed to inform you that **NORTH CENTRAL RAILWAY COLLEGE, TUNDLA DISTT** school managed by **MINISTRY OF RAILWAY** affiliated vide Affiliation No. **2130687** now stands affiliated under Govt. / Govt. aided category with

New Affiliation No. 2180033

Accordingly, the school would now quote the above New Affiliation No. in its all future correspondence including in all the school records alongwith the old Affiliation No. for further period of two years so that it can be co-related instantly. After two years, the school can quote only new affiliation No. allotted to it.

It is further, clarified that the concerned Ministry / Department / Govt. Undertaking / Society created by such Deptt / organisation which is running the school, shall now be responsible to develop and adopt well defined rules including service rules in confirmatory to State / U.T / Centre Education Act / Affiliation Bye Laws of the Board to govern the day today administration of the school. It is also the responsibility of the Management to notify the rules so adopted by it for the general information of all concerned.

With reference to your application dated 6.5.2004 and subsequent inspection of the school, I am directed to convey sanction for provisional affiliation to the above said school for Secondary School Examination (Class IX to X) and Senior School Certificate Examination (Class XI to XII) for a period of **three years** w.e.f. 01.04.2004 to 31.3.2007. The provisional affiliation for Senior Secondary stage shall be for the following subjects:-

The sanction is subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of provisional affiliation for secondary classes:

1. The school will follow the national syllabus for the middle classes.
2. The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Secondary School Examination and changes made therein from time to time.
3. The school shall appoint only qualified and eligible staff to teach Classes upto XII as per requirements laid down by the Board.
4. The school will help the Board in the smooth conduct of the examination by providing the necessary accommodations i.e. Rooms, Halls, etc. available in the school premises and furniture at its disposal for holding its examinations free of charges if required.
5. The school will spare sufficient teachers, for invigilation purpose at the examinations of the Board, as may be required
6. The school will spare its teachers for evaluation of answer-books for the Board's examinations, if required.
7. Service agreement be executed with the staff as per norms generally accepted by the State Government concerned.
8. Service conditions, pay and allowance and other benefits to the employees of the school shall be in no way less than that of corresponding employees working in Government Schools of the State in which the school is located.

9. The school and its records shall be opened for inspection by an officer/official of the Board or an authorised representative of the Board/State Educational Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.
10. The rate of tuition fee and other fees charged should be commensurate with the facilities provided.
11. The school will provide additional suitable facilities for classes XI and XII, as per requirements laid down in the rules.
12. It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board upto Classes XII.
13. It will provide facilities for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
14. The admission to the school shall be opened to all without any discrimination on the ground of religion, cast or race, place of birth or any of them.
15. No unrecognized classes shall run within the premises of the school or outside in the same name of school.
16. The School will not sponsor candidates for Board's examination of any other School/Branch, which is not affiliated.
17. The school will create Reserve Fund as per the requirement of the Affiliation Bye Laws/Rules of the Directorate of Education, Delhi in the joint names.
18. The affiliation Code Number allotted to your school is **2130687**. This may please be noted and quoted for any correspondence with the Board.
19. Annual fee @ Rs.1000/- per annum for the three year(s) be also remitted at an early date. (In case of overseas Independent school @ Rs. 5000/- p.a. and overseas Kendriya Vidyalayas @ Rs. 3500/- p.a.)
20. The school will apply for further Extension of Provisional Affiliation on the prescribed form together with the prescribed fee and other essential documents in the preceding year before the expiry of the date.
21. Renewal of Registration of Society be ensured.
22. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.
23. It will remit Annual Fee of Rs. 1000/- regularly. (In case of overseas Independent Schools @ Rs. 5,000/- p.a. and overseas Kendriya Vidyalayas @ Rs. 3,500/- p.a.).
24. Other conditions are as per Annexure 'A' enclosed.

Special Conditions, if any:

- There should not be any State pattern classes from the school campus w.e.f. session 2006-07.

Compliance of the above conditions should reach to this office with in **three** months from date of issue of this letter.

Other Conditions :

Conditions for which Compliance to be submitted with in three months from the date of issue of sanction letter :-

1. Running /Starting of class IX/X or XI/XII without prior Provisional Affiliation upto Secondary level /Sr. Secondary level from the Board would be unauthorised and school shall be responsible for the consequences arising out of it.

Non submission of application for extension of Provisional Affiliation by 30th June of the year preceding to the year by which provisional affiliation granted, expires, would also attract violation of provisions of Affiliation Bye Laws.

School will not prepare any student/start any class for any other Board except CBSE from their CBSE Affiliated school Building/premises.

4. The Board would not allow any transfer of property/sale of school by one Society /Management / Trust to another Society / Management / Trust through agreement /sale deed and the school shall not be closed down in the same premises. In case such transaction is effected explicitly or implicitly the board shall withdraw its affiliation with immediate effects.

5. Pay and allowances to staff should be revised from time to time to bring it at par with that to the State Government.

6. The service conditions be strictly followed as per State Education Act and staff be given appointment / Confirmation letters etc. accordingly.

7. 5-6 names of persons not below the rank of Principal of Sr. Secondary School affiliated with the Board be recommended so that two of them may be approved by the Board as its nominee in the School Managing Committee. Of these 2-3 may be Principal of KV/JNV

8. The School shall maintain Section teacher Ratio at least 1:1:5 at each level i.e. primary (I-V) Secondary (VI-X) and Sr. secondary (XI-XII)

9. The school has to constitute a committee for protection of women from sexual harrasment at the work place and to abide by the guidelines and norms prescribed by the Hon'ble Supreme Court of India in W.P. Criminal No. 666-70 of 1992 Vishakha and others state of Rajasthan and others delivered on 13/08/1997.

10. Rs. 2000/- on account of annual fee for three years may please be remitted.

1. The school shall maintain Reserve Fund in the joint names of the Manager of the school concerned and the Secretary of the Board in the scheduled Bank to the extent indicated below :-

501 -	750	"	Rs. 80,000
