Attention is invited to Board's letter No. E(W)2017/ED-2/3 dated 13.08.2018 (RBE No. 114/2018), whereby Ministry of Personnel, Public Grievances and Pensions (DoP&T)'s OM No. A-27012/02/2017-Estt.(AL) dated 17.07.2018, containing consolidated instructions for grant of CEA and Hostel Subsidy, was circulated for implementation on the Railways.

Now, the Ministry of Personnel, Public Grievances and Pensions (DoP&T) vide their OM No. A-27012/01/2023-Pers.Policy(Allowance) dated 14.03.2024 (copy enclosed) have issued modification to Para 2(p) of their OM dated 17.07.2018 and also communicated decision to grant one time relaxation for reimbursement of CEA/Hostel Subsidy to those employees whose children have to repeat one additional class due to New Education Policy 2020. Instructions in the enclosed OM dated 14.03.2024 shall apply mutatis-mutandis to Railway employees with effect from the academic year 2023-24 onwards.
